Construction Permit Fee (Residential)\$130.00
Construction Permit Fee (Commercial/Industrial)\$230.00
Soil Analysis / Site Assessment Fee\$120.00 For Upgrades & Lagoons only
Repair Fee\$ 50.00
Re-inspection Fee\$ 50.00
Permit Transfer Fee\$ 25.00
Homeowner (Do-it-yourself) Fee\$ 25.00
Water Well Permit Fee\$ 75.00

*The license shall cover a period of one year, from January 1 to December 31.
