RESOLUTION 17- 61

A RESOLUTION ESTABLISHING A NEW FEE SCHEDULE FOR THE FRANKLIN COUNTY

EMERGENCY MEDICAL SERVICE

WHEREAS, K.S.A. 19-101, provides that a county may exercise the powers of home rule to determine its local affairs and government as authorized under the provision of K.S.A. 19-101a; and

WHEREAS, K.S.A. 65-6101 et. seq. authorizes local municipalities to establish and operate emergency medical services and to establish and collect charges for emergency medical services; and

WHEREAS, Franklin County has established and provides emergency medical services for Franklin County, Kansas; and

WHEREAS, Franklin County has experienced the need to evaluate and adjust the service fees for emergency medical services; and

WHEREAS, the Board of County Commissioners believes that it is in the best interest of Franklin County to adopt a new fee schedule effective January 1, 2018.

THEREFORE, BE IT RESOLVED BY

THE BOARD OF FRANKLIN COUNTY COMMISSIONERS,

That the following resolution shall establish the fee schedule for Franklin County Emergency Medical Services effective January 1, 2018:
