COMPLAINT

I, Brandon L. Jones, Franklin County Attorney, of lawful age, being first duly sworn on oath, for complaint against the above-named defendant, alleges and states:

COUNT 1 - BATTERY

That on or about April 28, 2021, in Franklin County, Kansas, **MARK A. SAMSEL** did unlawfully and knowingly or recklessly cause bodily harm to another person, to wit: T.L.E. (DOB: xx/xx/2005), or knowingly cause physical contact with another person, to-wit: T.L.E. (DOB: xx/xx/2005), done in a rude, insulting, or angry manner, **a class B person misdemeanor**, in violation of K.S.A. 21-5413(a)(1), (a)(2), & (g)(1).

Penalty Range: From up to 6 months in the county jail and/or a fine up to \$1,000, pursuant to K.S.A. 21-6602(a)(2) & 21-6611(b)(2), and amendments thereto.

COUNT 2 - BATTERY

That on or about April 28, 2021, in Franklin County, Kansas, **MARK A. SAMSEL** did unlawfully and knowingly or recklessly cause bodily harm to another person, to wit: T.L.E. (DOB: xx/xx/2005), or knowingly cause physical contact with another person, to-wit: T.L.E. (DOB: xx/xx/2005), done in a rude, insulting, or angry manner, **a class B person misdemeanor**, in violation of K.S.A. 21-5413(a)(1), (a)(2), & (g)(1).

Penalty Range: From up to 6 months in the county jail and/or a fine up to \$1,000, pursuant to K.S.A. 21-6602(a)(2) & 21-6611(b)(2), and amendments thereto.

COUNT 3 - BATTERY

That on or about April 28, 2021, in Franklin County, Kansas, **MARK A. SAMSEL** did unlawfully and knowingly cause physical contact with another person, to-wit: J.G. (DOB: xx/xx/2005), done in a rude, insulting, or angry manner, **a class B person misdemeanor**, in violation of K.S.A. 21-5413(a)(2) & (g)(1).

Penalty Range: From up to 6 months in the county jail and/or a fine up to \$1,000, pursuant to K.S.A. 21-6602(a)(2) & 21-6611(b)(2), and amendments thereto.


