## A RESOLUTION AMENDING THE OFFICIAL ZONING DISTRICT MAP OF FRANKLIN COUNTY, KANSAS

WHEREAS, the Franklin County Planning Commission of Franklin County, Kansas, received an application for a Zone Change from Curtis Altic to rezone approximately 6.67 acres from the A-1, Agriculture District to the R-E, Residential Estate District. The property described below lies outside any incorporated city and is described as follows:

A tract of land in the North Fractional Half of Section 31-T15S-R18E of the Sixth P.M. written by Bryon K. Cates, PS 1208, dated October 20, 2022 as follows: Beginning at the Northwest Corner of the Northeast Quarter of Section 31; THENCE North 88°24'57" East 33.19 feet on the North line of said Northeast Quarter; THENCE South 02°11'43" East 800.00 feet; THENCE South 88°24'29" West 363.19 feet; THENCE North 02°11'43" West 800.00 feet to the North line of the Northwest Fractional Quarter; THENCE North 88°24'26" East 330.00 feet to the Point of Beginning containing 6.67 acres, more or less, all in Franklin County Kansas.

WHEREAS, pursuant to K.S.A. 12-757(b), the Franklin County Planning Commission has published in the official county newspaper on the May 24, 2022, notice of public hearing for said Zoning Change; and

WHEREAS, pursuant to K.S.A. 12-757(b), the Franklin County Planning Commission held a public hearing on June 16, 2022 regarding said Zoning Change; and

WHEREAS, the Franklin County Planning Commission, on June 16, 2022 in regular session and by a unanimous vote of those members present, recommended approval of said Zoning Change request based upon certain findings of fact, whereby recommending that the Official Zoning District Map of Franklin County, Kansas be amended; and

WHEREAS, the Franklin County Board of County Commissioners, after duly reviewing the recommendation of the Planning Commission and considering all public comments and concerns regarding said Zoning Change, find that the rezoning of said property would not be detrimental to the surrounding properties and would be in compliance with the provisions of K.S.A. 12-753, the purpose and intent of the Franklin County Comprehensive Plan and the general welfare of the citizens of Franklin County.

NOW, THEREFORE, BE IT RESOLVED, that the Franklin County Board of County Commissioners does hereby approve the rezoning of the above described tract from the A-1, Agriculture District to the R-E, Residential Estate District and that the Official Zoning District Map of Franklin County, Kansas be amended to reflect the approved zoning change.

PASSED AND ADOPTED by the Franklin County Board of County Commissioners this 16<sup>th</sup> day of November, 2022. This action shall become effective upon publication in the official county newspaper.


