RESOLUTION NO. 23- 08

A RESOLUTION AMENDING THE
OFFICIAL ZONING DISTRICT MAP OF FRANKLIN COUNTY, KANSAS

WHEREAS, the Franklin County Planning Commission of Franklin County, Kansas, received an application for a Zone Change from Jeremi and Kelli Thompson to rezone approximately 3.00 acres, described as Conveyance Tract, from the A-1, Agriculture District to the R-E, Residential Estate District. The property described below lies outside any incorporated city and is described as follows:

Conveyance Tract:

All that part of the Southeast Quarter Section 5, Township 16 South, Range 21 East, Franklin County, Kansas as prepared by Jeff Luthro RLS#1222, November 17th, 2022, described as follows: Commencing at the Southeast Corner of the Southeast Quarter of said Section 5; Thence N2°14'37"W along the East line of said Southeast Quarter a distance of 1237.50 feet; Thence S87°45'23"W a distance of 264.00 feet to the Point of Beginning; Thence S87°45'23"W a distance of 91.99 feet; Thence N2°14'37"W parallel to the East line of said Southeast Quarter a distance of 1422.77 feet to a point on the North line of said Southeast Quarter; Thence N88°05'46"E along said North line a distance of 91.99 feet; Thence S2°14'37"E parallel the East line of said Southeast Quarter a distance of 1422.23 feet measured (1402.50' deed) to the Point of Beginning, containing 3.00 acres more or less.

WHEREAS, pursuant to K.S.A. 12-757(b), the Franklin County Planning Commission has published in the official county newspaper on the December 24, 2022, notice of public hearing for said Zoning Change; and


WHEREAS, pursuant to K.S.A. 12-757(b), the Franklin County Planning Commission held a public hearing on January 19, 2023 regarding said Zoning Change; and

WHEREAS, the Franklin County Planning Commission, on January 19, 2023 in regular session and by a unanimous vote of those members present, recommended approval of said Zoning Change request based upon certain findings of fact, whereby recommending that the Official Zoning District Map of Franklin County, Kansas be amended; and

WHEREAS, the Franklin County Board of County Commissioners, after duly reviewing the recommendation of the Planning Commission and considering all public comments and concerns regarding said Zoning Change, find that the rezoning of said property would not be detrimental to the surrounding properties and would be in compliance with the provisions of K.S.A. 12-753, the purpose and intent of the Franklin County Comprehensive Plan and the general welfare of the citizens of Franklin County.

NOW, THEREFORE, BE IT RESOLVED, that the Franklin County Board of County Commissioners does hereby approve the rezoning of the above described tract from the A-1, Agriculture District to the R-E, Residential Estate District and that the Official Zoning District Map of Franklin County, Kansas be amended to reflect the approved zoning change.

PASSED AND ADOPTED by the Franklin County Board of County Commissioners this 8th day of February, 2023. This action shall become effective upon publication in the official county newspaper.
