RESOLUTION NO. 16- 116

A RESOLUTION APPROVING AN AMENDMENT TO THE OFFICIAL COUNTY ZONING MAP TO RE-ESTABLISH COUNTY ZONING FOR THOSE PROPERTIES FORMERLY DESIGNATED WITHIN THE BOUNDARIES OF THE URBAN GROWTH AREA OF THE CITY OF OTTAWA ESTABLISHED PURSUANT TO THE INTERLOCAL AGREEMENT BETWEEN FRANKLIN COUNTY AND THE CITY OF OTTAWA DATED JUNE 30, 2006 WITH THE EXCEPTION OF THE PRAIRIE PAWS ANIMAL SHELTER PROPERTY BEING REZONED TO THE "I-1" LIGHT INDUSTRIAL ZONING DISTRICT.

WHEREAS, Franklin County, Kansas is a county municipal government, organized pursuant to K.S.A. 19-101; and

WHEREAS, The Franklin County Board of County Commissioners did adopt Resolution # 23-91 creating the Franklin County Planning Commission as provided in K.S.A. 12-744; and

WHEREAS, the Franklin County Planning Commission did publish notice as required by K.S.A. 12-757 that a public hearing would be held to consider amending the County Official Zoning Map re-establishing County Zoning for properties previously designated within the Urban Growth Area of the City of Ottawa and rezoning the Prairie Paws Animal Shelter to the "I-1" Light Industrial Zoning District; and

WHEREAS, the Franklin County Planning Commission, on July 21, 2016 in regular session and by a unanimous vote of those members present, did find such amendments to the County Official Zoning Map to be in the public interest and necessary to promote the health, safety, convenience, prosperity and general welfare of the Citizens of Franklin County Kansas; and

WHEREAS, the Franklin County Board of County Commissioners, after duly reviewing the recommendation of the Planning Commission and considering all public comments and concerns regarding said amendments, find that the amendments to the County Official Zoning Map to be in the public interest and necessary to promote the health, safety, convenience, prosperity and general welfare of the Citizens of Franklin County Kansas.

NOW, THEREFORE, BE IT RESOLVED, that the Franklin County Board of County Commissioners does hereby approve the re-establishment of the County Zoning for those properties formerly designated within the boundaries of the Urban Growth Area of the City of Ottawa established pursuant to the Interlocal Agreement between Franklin County and the City of Ottawa dated June 30, 2006 and the rezoning of the Prairie Paws Animal Shelter facilities to the "I-1" Light Industrial Zoning District and that the Official Zoning District Map of Franklin County, Kansas be amended to reflect the approved zoning change.

PASSED AND ADOPTED by the Franklin County Board of County Commissioners this 24th day of August, 2016. This action shall become effective upon publication in the official county newspaper.
