A RESOLUTION OF THE FRANKLIN COUNTY BOARD OF COUNTY COMMISSIONERS APPROVING AMENDMENTS TO THE COUNTY COMPREHENSIVE PLAN ENTITLED FRANKLIN COUNTY KANSAS 2006 – 2026 COMPREHENSIVE PLAN IN ACCORDANCE WITH K.S.A. 12-747

WHEREAS, Franklin County, Kansas is a county municipal government, organized pursuant to Kansas Statutes K.S.A. 19-101; and

WHEREAS, the Franklin County Board of County Commissioners did by Resolution #23-91 create the Franklin County Planning Commission as provided in K.S.A. 12-744; and

WHEREAS, the Franklin County Board of County Commissioners did adopt the Zoning Regulations of Franklin County, Kansas on August 4, 2002 as provided in K.S.A. 12-757; and

WHEREAS, the Franklin County Planning Commission published a notice on May 27th, 2010, that a public hearing would be held to consider adopting a revised Comprehensive Plan as prescribed by K.S.A. 12-747(b); and

WHEREAS, the Franklin County Planning Commission did, on June 17th, 2010, hold a Public Hearing for the consideration of adopting a new County Comprehensive Plan as prescribed by K.S.A. 12-747(b) and K.S.A. 12-743; and

WHEREAS, the Franklin County Planning Commission has reviewed in detail, studies, maps, policies and other materials as set forth in the Comprehensive Plan entitled “Franklin County Kansas 2006-2026 Comprehensive Plan” regarding the Urban Growth Area for the City of Ottawa and the K-68 Highway Corridor Management Plan; and

WHEREAS, the Franklin County Board of County Commissioners, after duly reviewing the recommendation of the Planning Commission and considering all written reports, public comments and evidence regarding the Urban Growth Area for the City of Ottawa and the K-68 Highway Corridor Management Plan.

NOW, THEREFORE, BE IT RESOLVED, that the Franklin County Board of County Commissioners does hereby approve the adoption of an amendment to the County Comprehensive Plan entitled “Franklin County Kansas 2006 – 2026 Comprehensive Plan” to the Future Land Use Map to include the Urban Growth Area for the City of Ottawa and the K-68 Highway Corridor Management Plan Boundaries.
