RESOLUTION NO. 08-024

A RESOLUTION AMENDING THE  
OFFICIAL ZONING DISTRICT MAP OF FRANKLIN COUNTY, KANSAS

WHEREAS, the Franklin County Planning Commission of Franklin County, Kansas, received an application for a Zone Change from Levi Spratt, to rezone approximately 10.00 acres from an A-1 (Agriculture) District to an R-E (Residential Estate) District. The property described below lies outside any incorporated city and is described as follows:

Tract 1:

Commencing at the Southeast Corner of the Northeast Quarter of Section 19, Township 17 South, Range 21 East; THENCE North 00 degrees 02 minutes 23 seconds East 422.48 feet along the East line of said Quarter Section to the TRUE POINT OF BEGINNING; THENCE North 89 degrees 57 minutes 37 seconds West 1138.62 feet; THENCE North 00 degrees 02 minutes 23 seconds East 382.57 feet along a line parallel with the East line of said Quarter Section; THENCE South 89 degrees 57 minutes 37 seconds East 1138.62 feet to a point on the East line of said Quarter Section; THENCE South 00 degrees 02 minutes 23 seconds West 382.57 feet along the East line of said Quarter Section to the POINT OF BEGINNING, all in Franklin County Kansas. Subject to any part thereof in roads.

WHEREAS, pursuant to K.S.A. 12-757(b), the Franklin County Planning Commission has published in the official county newspaper on the 26th day of March 2008, notice of public hearing for said Zoning Change Request; and

WHEREAS, pursuant to K.S.A. 12-757(b), the Franklin County Planning Commission held a public hearing on April 17th, 2008 regarding said Zoning Change Request; and

WHEREAS, the Franklin County Planning Commission, on April 17th, 2008 in regular session and by a unanimous vote of those members present, approved said Zoning Change request based upon certain findings of fact, whereby recommending that the Official Zoning District Map of Franklin County, Kansas be amended; and

WHEREAS, the Franklin County Board of County Commissioners, after duly reviewing the recommendation of the Planning Commission and considering all public comments and concerns regarding said Zoning Change, find that the rezoning of said property would not be detrimental to the surrounding properties and would be in compliance with the provisions of K.S.A. 12-753, the purpose and intent of the Franklin County Comprehensive Plan and the general welfare of the citizens of Franklin County.

NOW, THEREFORE, BE IT RESOLVED, that the Franklin County Board of County Commissioners does hereby approve rezoning of the above described tract of land from an "A-1" Agriculture District to an "R-E" Residential Estate District and that the Official Zoning District Map of Franklin County, Kansas be amended to reflect the approved zoning change.
