To vote against it, darken the oval to the left of the word "NO".</p> <p>Shall the following be adopted?</p> <p>"Shall the following ordinance become effective as required by K.S.A. 25-3061(c) that the governing body of the City of Pomona be allowed to adopt the Charter Ordinance No 16 I.A.W. with section 2 Substitute Provisions regarding the appointment and hiring of city officers for the City of Pomona. Exempting the City of Pomona from K.S.A. 15-204 and subject to the provisions of K.S.A. 2008 Supp. 12-16-128, and amendments thereto. The Mayor, with the consent of the council, may appoint at the first meeting of the governing body in May of each year the following city officers: municipal judge of the municipal court, a marshal-chief of police, law enforcement officers and any other officers as deemed necessary, with the exception of the city clerk, city treasurer, city attorney and city zoning administrator/ordinance enforcement official are to be hired as employees at-will. Such appointed officers shall hold an initial term of office not to exceed one year and until their successors are appointed and qualified. Any officers who are reappointed shall hold their offices for a term of one year and until their successors are appointed and qualified. The duties and pay of various officers shall be regulated by ordinance. Any officer appointed pursuant to this Charter Ordinance may be removed by a majority vote of the total membership elected or appointed to the council and may be suspended at any time by the Mayor.
